- To provide accountability
- For analysis and learning

- For advocacy (of research)

There is a growing need to show clearly the impact of research and to provide evidence that publicly funded research presents a good return on investment for the research funders and ultimately, the tax payer.

Research evaluation has emerged as a key issue in many industrialized countries, where universities are faced with demands for greater accountability and the consequences of diminished funding. Many countries have introduced evaluation of university research. In the present time universities are expected to be both efficient and accountable.
